

B.S.A. TROOP 215: SUMMARY OF ON-GOING FINANCIAL MATTERS

Subject	Committee Date or other Source
Camping Refunds	Oct. 4, 2011
If Scout or adult signs up for a camp-out, but does not attend, then his escrow will only be reimbursed under certain circumstances (hospitalized, etc.)	
Dues	Mar. 6, 2012
Dues are due beginning the month after the Scout joins the Troop. There is no discount for paying the years' dues in advance	
Equipment Use	Troop Handbook (page 22)
Equipment loaned to a Scout for personal use must be returned by the Tuesday meeting following the camp use. A fee of \$5.00 will be charged for late returns. The full price of the item will be billed for items not returned by the following week's meeting.	
Fundraisers	Nov. 6, 2012
All fundraising activities not specifically allocated to a particular fund (hot dog sales, etc.) will be split between the Scouts attending the fundraiser based on number of hours worked.	
Garage Sales	Nov. 6, 2012
Proceeds from garage sales and any other fundraiser held on the same day will be allocated to the summer camp transportation fund.	
Gillenwater Scholarship	Jan. 3, 2012
February dues will be allocated to the scholarship fund. Scholarship limit is \$250.00	
Inactive Scouts	Troop Handbook (page 20)
A Scout may request, in writing, to be placed on "inactive" status. Once a Scout is placed on "inactive" status, monthly dues will cease to accrue. Once the Scout decides to return to the Troop, he will need to pay a \$25.00 re-activation fee.	
	Nov. 6, 2012
It was determined that the re-activation fee would only be due from those Scouts who were inactive at re-charter and, therefore, were not included in the recharter.	
Merit Badge Books	Sept. 18, 2012
Scouts will be credited \$3.00 for each merit badge book they donate to the Troop's library. The Merit Badge book must be current to receive the credit.	
Mileage	April 3, 2012
The adult who hauls the Troop trailer on camping outings will be reimbursed \$0.50 per mile.	
NYLT Scholarship	May 3, 2011
\$50 scholarship for Scout attendees and Scouts on staff at NYLT when Scout turns in a copy of his NYLT certificate to Treasurer.

O.A. Scholarship Sept. 6, 2011

\$500 was set aside for O.A. service weekends. Funds will be disbursed to the Troop's Arrowmen attending an O.A. service weekend on a first-come first-served basis.

Popcorn Booths Nov. 6, 2012

Proceeds from each individual booth will be split between the Scouts working at each booth based on number of hours worked. If there are multiple booths open on the same day, but at different venues, proceeds from the different venues will not be combined -- each booth's proceeds is to be allocated separately.

The fee for transferring from a Pack or Troop is \$1.00
